a. Report

- 2. There was a meeting yesterday (Aug 17th) so all staff employees could better understand budget, planning, revenue, expenses, etc.
- 3. It's important to be involved in the conversation on what faculty can do to bring in revenue and advocate for sound decisions.

- a. Report
 - 1. Marty stated the Facilities Committee is a meeting where someone can be informed on what is happening in regard to construction including at the district level.
 - 2. They review anything from construction to cleanliness. They are different task forces. One task force that is beginning is safety.
 - 3. Facilities Committee meets on the third Tuesday of the month at 1:30pm. They are open meetings, and everyone is encouraged to attend.

- 1. Jim Isbell expressed that faculty needs to be involved so faculty voices can be heard in all these different committees.
- 2. Jim also asked if there are any issues faculty will like for the Senate to address this semester.
 - 1. Amberly Chamberlain stated that she noticed in the past that no action was taken on items that were presented during open discussions. She requested for such items to be revisited. Jim agreed that if Senate doesn't take action, explain why; be transparent.
 - 2. Molly Colunga would like to understand the approval process better such as first reading, second reading, etc.
 - 3. Quynh Mayer requested for clarification on Senate policies and procedures. Direct senators to where they can retrieve this information.
 - 4. Susan Hoang requested information on how to participate accordingly in meetings via Zoom, as well as more transparency on how to add an item to the agenda.
 - 5. Stephanie Clark proposed that there is an opportunity this fall for Academic Senate to invite a guest speaker to present on Roberts Rules. A basic training that will empower everyone.
 - 6. Dr. Lamb noticed an opportunity centered around mentorship and general support for faculty on Academic Senate. Use Faculty Institute as a vehicle to incorporate this type of training.

7. Introduction to Cornerstone – Amberly Chamberlain

- a. Amberly announced that the new professional development (PD) tracking system is called SAC PD Gateway. No longer referenced as Cornerstone.
- b. It's a statewide and robust system with over 8,000 PD opportunities. PD is in your hands by being able to participate in workshops that are offered throughout the state.
- c. There's a Gateway training this Friday, August 20 at 8am in the SAC computer lab. In addition, there will be Q & A hour every day this week.
- d. If someone is having difficulty registering for a meeting or workshop that you are facilitating, please send them the Zoom link so they can attend because their information can always be added at a later time.
- e. Use your SAC credentials SAC email and password to log-in to Gateway. If you are having issues logging-in, contact IT Help Desk.
- f. Faculty have the most buttons to use in Gateway. Flex status is where you will find your report. It displays your obligation and how much you have completed to date.
- g. Transcripts demonstrate your training registration and completion status. Many activities have a mandatory evaluation to complete the training and receive the credit for it.
- h. Workshop calendar is the best place to find what is being offered. If someone is only interested in seeing SAC offerings, they can change the location. It's set up to display all of SAC and Santiago Canyon College trainings.
- i. Check your homepage to see if your flex obligation is correct. If not, contact your dean.
- j. Proposing a workshop takes to 2-3 days to be built into the system. It's form that needs to be completed.
- k. My flex workshop is where you will enter your personal flex projects.
- 1. Part-timer are expected to complete their flex obligation every semester in case they don't receive a teaching assignment the following semester.
- m. July 1st is the start date for faculty to start working on their flex obligation.
- n. EEO and other district training will be added to the system. As of right, the district isn't connected to Gateway.
- o. If you are a senator, it's part of your role and service to attend the Academic Senate retreat and regular business meetings. Thus, attending those don't count toward your flex obligation. But if you are not a senator and you participated during PD week, it does count. This includes the regular business meetings. Nonetheless, your dean would need to approve it.
