I. <u>Call to Order</u>

- **A.** President Jones called the meeting to order at 1:30 p.m.
- B. Introduction
- **II.** <u>Agenda Accepted</u>— A motion to approve the agenda made by Susan Garnett and seconded by Teresa Simbro was unanimously approved.
- III. Public Comments—None
- **IV.** <u>Approval of the Minutes</u>—Tabled to the next senate meeting.

V. Topics

- **A.** Non-credit Presentation—Susan Gaer presented information regarding the ratio of full-time faculty at CEC to full-time faculty at SAC. It was reported that 25% of FTEs are provided by CEC. Susan stated that CEC is hiring 7 coordinators, and 1 teacher, due to the stipulations with the duties of teachers versus coordinators with regard to funding sources. A handout of Quick Facts was provided.
- **B.** Board of Governors Fee Waiver—Sara Lundquist, Vice President, Student Services, introduced Janice Love as the first Director of Research at SAC. Sara Lundquist and Robert Manson, Associate Dean of Financial Aid, provided information regarding the importance of notifying students early if they are not passing courses, as the BOG Fee Waiver sanctions go into effect this fall 2016 for the first time. Faculty was urged to tell students, prior to spring break, what they need to do in order to be successful in classes. Faculty was also urged to give students extra credit for taking a screen shot of their GPA, as student awareness is key. Signs have been posted across campus and in every classroom to alert students of the required 2.0 GPA. At the present time, over 1,000 students will be unable to continue with the BOG Fee Waiver in fall 2016.

VI. Reports

A. President—Elliott Jones

- 1. President Jones reported that losing 1,000 students in fall 2016 could substantially affect the landscape and health of the college, both educationally and fiscally.
- 2. Concerns about shortages of student parking were raised by faculty. President Jones stated that this issue has been raised in both the Facilities Committee meetings and the Planning and Budget Committee meetings, and will continue to be examined during construction.
- 3. President Jones reported that the District Foundation's contract to provide educational services in Saudi Arabia has encountered delays with Saudi government approvals that have raised questions about the viability of the project.
- **4.** Thanks was expressed by President Jones for all of the faculty serving on hiring committees, especially those who have accepted positions on committees outside their discipline.
- **5.** The 1st reading of the proposed new Board Policy on gifts for district employees (BP 3821) took place at the Board Meeting on Feb. 22nd. President Jones reported that he will convey concerns raised by faculty to the Board at the next BOT meeting.
- **6.** There was a District Council Meeting on Monday, March 7th at which the Tentative Budget Assumptions were reviewed. Vice Chancellor Peter Hardash indicated at that meeting that further reductions to COLA in the governor's May revise were possible, but current Budget Assumptions are still an increase of .47%. President Jones reported that the Chancellor accepted the recommendations of the FRC regarding funding of marketing at the colleges.
- 7. A request was made by President Jones for faculty to serve on both college and district shared governance Committees, in particular the SAC Planning and Budget and Facilities committees.
- **8.** Per Monica Porter, please continue to spread the word about the SAC Open House and Expo on Saturday, March 12th, 10:00 a.m. 2:00 p. m. The tickets are sold out for the Alumni Luncheon.
- **9.** There will be a follow-up to the Convocation, per Mary Huebsch, on Wednesday, March 23rd, at The Spot.
