Resolution: S12.01 Academic Senate support of re-alignment of American Sign Language program to Humanities Division

Whereas, The American Sign Language certificate (sac.sign.ca), formerly known as the Sign Language Education Option certificate (SAC 0995), currently housed under the Disabled Student Programs and Services program within Student Services division is an academic program that provides students with training in American Sign Language (ASL) and American Deaf culture;

Whereas, The ASL certificate program offers courses approved under the Associate degree Area C: Humanities and D. Cultural Breath; General Education credit for CSU (Plan B) under C2: Humanities; and Intersegmental General Education Transfer Curriculum (IGETC) Area 3: Group B: Humanities;

Whereas, Curriculum is integral to the ASL program, deeming it appropriate to have alignment with an academic curriculum committee of disciplines with like pedagogies;

Whereas, The curricula for study of languages (English, French, Japanese, Spanish and Vietnamese and English as a Second Language) at Santa Ana College are housed in the Humanities and Social Sciences Division;

Whereas, ASL courses offered on 19 of 23 southern California community college campuses are housed in the Humanities/Languages/World Languages/Modern Languages/Foreign Languages/Language Arts/Liberal Studies/Communication divisions; UCLA and UCSD offer their ASL courses under the Colleges of Linguistics; CSUF ASL classes are under Foreign Languages; and CSULB are under Liberal Arts/Linguistics;

Be it resolved as follows: That the Academic Senate at Santa Ana College, acknowledging the validity of American Sign Language as a full and natural language and that the study of the language and culture is an academic endeavor requiring alignment to an academic curriculum committee, supports the movement of the ASL program from the Student Services division, as a stand-alone department, to the Humanities wing of the Humanities and Social Sciences Division.
