4. **Public Comments**
 1. Louise Janus spoke on behalf of Student Services and concerns over faculty positions gravitating towards director and admin positions. Important faculty voices are being lost.
 2. Alejandro Moreno expressed concerns over scholarship information and a struggle to receive communication on the non-credit side.
 3. New Science Center has major and multiple safety concerns. See letter presented by Jennifer McAdam for details.
5. **Reports**
 1. **ASG Report** – Vice President Francisco Ramos
 - Not present to report.
 2. **SCC Report** – Prof. Tara Kubicka-Miller
 - Claire Coyne gave the report in Prof. Kubicka-Miller's absence. Numerous comments were made at their Senate meeting regarding faculty hiring; issues with safety vendors; SCC President sending an email asking to be informed of any classified intentions of making public comments at the Board meeting; a presentation was given on fraudulent students – trying to catch them requires faculty being proactive – everyone needs to understand how these students affect our data for classes. Classes being cancelled also affects faculty income. State is trying to enact safeguards and procedures to catch fraudulent students before they register. Lastly, SCC Senate approved their DE Handbook.
6. **Action Item**
 1. **DE Handbook**, presented by Prof. Jaki King (Second Read)
 - Changes:
 - Updated language on page 6, to create a more collaborative/collegial relationship between these recommendations. Before it said **or** which could imply that deans/managers might recommend a deferment without the

recommendation of the faculty chair.

- DE faculty advisory board reviewed feedback about creating an updated Remote Instruction Certificate for those who only teach DINT 4 modality (in person hybrid with zoom); however, after concerns and a discussion with the SCC Faculty Coordinator, this would put SAC *out of alignment with SCC in regards to training*. According to the DE office, between SU23 and FA23 there were only a total of 12 DINT 4 courses, and all but one of those instructors are Online Certified; the one that is not is scheduled to take it in the Summer.
 - Kelvin Leeds mentioned there are more in his department than are being stated.
- Updates will be being made over the summer to Canvas for DE certification. The Advisory Committee is worried about having the staff to do all the work that needs to be done to update and address problems.
- Questions still remain on how DINT 4 could meet the SLOs without requiring the full 120 hours needed for completion of the certificate. Some faculty feel it's too much and unnecessary for a synchronous live class and that a synchronous live course needs a different, more specialized training than is offered with the OTC. Though there isn't much concern because there aren't many faculty/courses impacted by this, what happens if another pandemic were to occur and force courses online again?
