 - a. Shared the Draft of the Resolution:
 - b. Luis Pedroza suggests approving this today and bypassing the second read.
 - c. Michael Taylor asked about the 3rd resolved about including district resources.
 - d. Jorge Lopez asked about a title IX process. Is this duplicating this work?
 - e. Annie Knight commented about Jorge's question. She doesn't see this as a duplication, in her mind she sees this as opportunities for collaboration and additional support that's needs through Senate to support the campus in doing this work. Not a duplication, a necessary thing to be stated and understood in taking responsibility with what we can do in the Senate.

- f. Michael Taylor shared that Title IX covers investigation and information. We want to be collaborative; we have our voice and there are other ways of getting this information out there.
- g. Susan Hoang, she feels this resolution is written broadly enough to acknowledge that there are other things happening. Responsibility and onus is on the Academic Senate to address these things. There are things we can do to address systemic issues. Overlap is going to be necessary to discuss in this workgroup.
- h. Maria Estrada thinks this is the first time we are addressing these issues. There will be collaboration for the accountability factor. When issues are not being resolved.
- i. Jennifer Meloni sees this as another layer that affirms what is happening already at the administrative level through our Title IX officer. Jennifer said some may call it duplication, but it is more affirming at the faculty level rather than the administrative level. Partnership to provide training.
- j. Not specific except to establishes a workgroup, nitty gritty isn't approved now, but establishing this platform and working alongside the administrative level.
- k. Roy assumes that if the Senate approves this workgroup these can be defined.
- 1. Jennifer is wondering how this workgroup will be formed. Any guidelines around establishing the 'who' and what the workgroup represents?
- m. Roy said once a workgroup is established, we try to create a one page summary of the workgroup and outlining the membership and assignment of membership.
- n. Luis Pedroza is motioning to adopt the resolution as a first read, Stephanie Clark seconded.
- o. Jim Isbell asked about second reads and also about trainings as far as obligations.
- p. Stephanie Clark shared that trainings could come in many different ways, such as how to manage meetings to create equitable spaces, may not be obligatory but could certainly be recommended.
- q. Rebecca asked about the culture of this workgroup, recommend training for campus leaders, even in consideration of appointments in the future. This member has received training in specific areas that the Senate is now proposing to value.
- r. Luis has a question, once this is accepted can the words be tinkered around with? What about a word such as 'advocate'?
