4. <u>PORTFOLIO ASSESSMENT/PROGRAM REVIEW REPORT FROM TLC</u> Bonnie informed the council that TLC will review and assess the PA/PR process now that one complete cycle has been done. Annotations will be added to the 19QT to clarify the types of data needed to respond to certain questions. In the fall semester, PA/PR workshops will be provided for the chairs whose departments are in the 2011-2012 cycle. In addition, the TLC will designate one person per division to serve as a resource to the faculty in that division as departments are going through the PA/PR process. 5. <u>COMPUTER SKILLS AND APPLICATIONS REQUIREMENT</u> <u>INFORMATION</u> Bonnie informed the council that SCC has requested that the vote on this item be delayed because the taskforce is working on a proficiency type "credit by exam" which will encompass different disciplinary aspects. Allen Dooley, Dean of Business, has joined this group and is researching different instruments. There will be a report in the fall.

6. COOPERATIVE WORK EXPERIENCE

INFORMATION

Chris Truong presented information related to 1. *Cooperative Work Experience* — Title 5, 55044 "Repetition of Variable Units Courses." Changes for the 2012-2013 catalog are as follows: Instead of 1-4 units repeatable three times, it is recommended to express the total as 1-16 units (i.e., the total number of units for a course). 2. A Title 5 change will limit the number of times a student may repeat and withdraw from the same class as a result of apportionment limitations to districts. A student may only take a credit class three times in the same credit course (certain exceptions will apply, e.g., military withdrawal and students with disabilities enrolled in special courses for the disabled). Districts would still be permitted to allow a student to enroll in the same course beyond the 3+1 limit without generating state apportionment based on local petition or appeal policies. Further information is forthcoming.
