COURSE PARTICIPATION & ATTENDANCE

A workgroup presented the revised language to the council. It was moved, seconded, and approved by the council members to move the new policy language to the Academic Senate. Monica Porter and Madeline Grant will bring this item to the SAC Academic Senate for review.

Current Policy:

Absence/Drop It is the student's responsibility to withdraw officially from a course.

However, because of enrollment demand a student may be dropped by the instructor when not appearing at the first class meeting.

A student may be dropped for excessive absences when the total hours of absences exceed 10% of the total, scheduled hours of the class.

Under extenuating circumstances, a student may be reinstated by the instructor.

INFORMATION

Proposed Policy:

Absence/Non Participation/Drop

It is the student's responsibility to withdraw officially from a course.

However, because of enrollment demand a student may be dropped by the instructor when not appearing at the first class meeting or not participating in the first course activity designated to account for active enrollment.

A student may be dropped for non participation if they have missed in excess of 10% of the total course activities including but not limited to class attendance, discussions, assessments, etc.

Under extenuating circumstances, a student may be reinstated by the instructor.

ARTICULATION OFFICER REPORT

Paula Canzona has been submitting courses for C-ID. She reminded the council members to make sure that Course Outline of Records are current. Also, any course submitted to C-ID must have current textbook information listed.

ACCREDITATION REPORT

A. Dr. Rose informed the council regarding the accreditation process that is currently under way on our campus. The tie of SLO's to the standards was also discussed. The ACCIC website was highlighted as a faculty resource for further information regarding accreditation standards and outcomes.

B. Dr. Rose informed the council regarding regulations on TBA hours. Dr. Rose requested that council members take information back to division curriculum committees to make sure that Divisions are in compliance with the identification of TBA hours, for applicable courses, in the course catalog. TBA compliance will continue to be reviewed during our audits, and our upcoming accreditation site visit.
