Monica requested that the C&I Council members share this document with their faculty at their Division Curriculum meeting and bring back any suggestions for improvement.

3. Brief discussion ensued about ways to have SLO's more accessible to the public. Suggestions included placing course SLO's on individual Department Websites. Monica requested that the C&I Council members bring any additional thoughts/ideas back to the next C&I Council meeting.

4. Brief discussion took place regarding a possible change to the dates of submission of curriculum by faculty for review by the technical committee and C&I Council members. In efforts to provide the council with adequate time for review of all course outlines prior to approval, a change is recommended. Monica will work with Anh-Phuong on this item and bring information back to the council.

5. Monica is currently working on updating SAC's Curriculum & Instruction Handbook. Monica hopes to have a draft available for council review by the next C&I Council meeting.
