V. Reports and Announcements a. Assembly Bill 928

P. Canzona reported on AB 928 which requires a single lower division general education pathway agreement to be finalized by December 31, 2023 and implemented by 2025-2026. She explained that the Intersegmental Committee of the Academic Senates (ICAS) shall establish the General Education (GE) pathway by May 31, 2023. If ICAS fails to establish the GE pathway, administrative bodies of the CCC, CSU and UC systems shall establish the GE pathway by December 31, 2023.

P. Canzona shared the proposed GE pathway which is being referred to as CalGETC. The proposal includes the number of courses required in academic areas (i.e. English, Communication, Arts and Humanities) to arrive at 11 courses, totaling 34 units. She commented on the potential impacts the new pathway will have on Lifelong learning and the reduction of courses in Arts, Humanities, Social and Behavioral Sciences.

P. Canzona provided ways for committee members to express their opinions by completing the survey monkey (<u>https://surveymonkey.com/r/GE_Pattern_Survey_2022</u>) by September 30, 2022 and by attending the various webinars offered through the ASCCC (Academic Senate for California Community Colleges) throughout the Fall 2022 semester.
