V. OC Community College Faculty Convening Presentation

C. Coyne reported that she, D. Roper, and M. Taylor, along with many other RSCCD faculty, attended the Orange County Community College Faculty Convening Presentation on November $4 - 6^{th}$ at the South Coast Winery in Temecula. She asked D. Roper and M. Taylor to share some insights.

D. Roper stated that the faculty convening was a good experience. He commented about the meaningful changes focused on equity. He also shared some of the experiences the students in his discipline and Welding face.

M. Taylor mentioned that the convening was very educational, where the needs are the same. Two (2) points he walked away with were (a) equity is a big issue where training for faculty is necessary, this should include classified and management; (b) faculty should look at a way for Workforce Development to offer work experience and/or a transitional path to actual jobs. He also mentioned that a regional proposal for grants should be considered.

Discussion ensued.
