DE Modalities

 These are the agreed upon definitions with SCC. However, they made recent updates. We are awaiting final President decision. The modalities below will remain, but the verbiage may be updated.

FULLY ONLINE INSTRUCTION (O) Classes are distance education classes that meet 100% online with no scheduled meeting days. Students logon to Canvas at <u>sac.canvas.edu</u> and complete work regularly throughout the week. Canvas and other technologies will be required to complete coursework.

FULLY REMOTE LIVE INSTRUCTION (RL) classes are distance education classes that only meet in scheduled live streaming Zoom meetings. Students logon to Canvas at <u>sac.canvas.edu</u> to attend class virtually on zoom during the published course times. Canvas and other technologies will be required to complete coursework.

ON-CAMPUS HYBRID INSTRUCTION (H) classes are distance education classes that combine scheduled on-campus meetings and online instruction. Students will attend class on-campus during the published course times and will logon to Canvas at sac.canvas.edu and complete work regularly throughout the week. Canvas and other technologies will be required to complete coursework.

VIRTUAL HYBRID INSTRUCTION (VH) classes are distance education classes that combine scheduled live streaming Zoom meetings and online instruction. Students will attend class virtually on Zoom during the published course times and will logon to Canvas at sac.canvas.edu and complete work regularly throughout the week. Canvas and other technologies will be required to complete coursework.

ON-CAMPUS (C) classes are on-campus and in-person with scheduled meeting days and times. Students will complete their course on campus.

DE Addendum

- Updates required for new DE modalities and clarity
 - Worked on and finalized the DE Addendum to include all asynchronous and synchronous modalities. Recommended proposal to CIC attached.

Regular Effective Contact Policy

- Submitted to Academic Senate first read (9/28/21)
- Would like to delete out "Online Attendance and Drop Policy". This was an oversight and is SCC's policy. SAC's "Absence/Non-Particiaption/Drop" is in the catalog and suggested syllabi verbiage is in our <u>Recommended Course Outline Additions</u>.
 - Electronic vote (carry over item) completed 10/7/21 and submitted updated policy to Academic Senate.

Educational Multimedia Studies

- Discussion regarding a plan to move Educational Multimedia Studies (EMS) out of Academic Affairs to the PIO office.
 - Concern is loss of faculty support for video and captioning training and assistance. This would impact faculty creation of important videos needed for improved student engagement and learning.
 - Voted to advocate as the DE Advisory Group to keep EMS under Academic Affairs with a continued allocation of time to PIO/Campus needs.

Training Requirement for Synchronous, Remote Live, modality

- Discussion regarding Online Teaching Certificate (OTC), Remote Instruction Certificate (RIC) and/or additional training requirement.
 - Concerns
 - Quantity of time and effort required on the part of faculty.
 - OTC Facilitation problems with faculty that expect to teach only in the Remote Live modality.
 - Multiple requirements for Distance Education.
 - Remote Live is a DE modality requiring online grades, online assessments, regular effective contact. Current RIC faculty believe their course is simply a replacement of Zoom for Lecture time.
 - Add skill building training to RIC faculty for RL.
 - Students not receiving the best course possible with fully training faculty.
- Will be meeting again on 10/20 for further discussion and hopeful decision.
