All Hands on Deck: To Increase and Improve Student Success in Transitioning from Non-credit to Credit

Long-Term Goals: 1. <u>Double the number of SCE High School Program graduates who transition to SAC credit from current 25% to 50%.</u>

2. Increase persistence of ESL and other non-credit discipline students at SCE and create a seamless transition to credit.

SCE Counselors will:

Provide student counseling to help students identify personal, financial and academic barriers.

Design a standardized educational plan that includes transition planning for all HS program, vocational and ESL students.

Train all SCE counselors in the use of the standardized educational plan.

Implement an educational/transition plan for all SCE students.

Lead dialogue between credit counselors and non-credit counselors on transition issues (academic, personal, etc.)

Develop a "referral" form for SCE instructors to use in supporting student success.

Non-credit Instructors will:

Attend training in the transition process and information about college-wide programs and support services so they can assist students in the classroom and make it relevant to their discipline.

Consider opportunities to engage with likediscipline credit instructors with their students.

Short-Term & Intermediate Objectives:

What can we accomplish in next 6 months, 1 year or 2 years?

- **1.** Provide 100% of SCE High School program students with an academic plan that includes a transition to credit.
- **2.** Increase the % of HS grads that transition to credit by 10% each year.
- **3.** Develop SCE to credit math, English, ESL and vocational articulation agreements to facilitate student transition.

Support staff will:

Outreach to all SCE HS potential grads (students with less than 20 credits to complete) to begin the matriculation process in a timely manner.

Assist SCE HS grads and SCE students from other non-credit discipline in the matriculation process at SAC, including application, financial aid, placement testing, connecting to counseling at SAC and other support programs at SAC.

Train both SCE and credit support staff on the needs of matriculating transitioning students (MIS reporting, SARS, SSSP, etc.)

Work with counseling and faculty to carryout special events and projects at CEC and SAC.

Provide training on AB540 to SCE instructors and staff.
