Board of Trustees Evaluation Survey

At its meeting on October 14, 2013, the board made a determination to use a survey as a process by which comments would be solicited for the self evaluation process.

You are being asked to complete an online Board of Trustees Evaluation Survey as stated in Board Policy 9022:

Some district students, employees, and residents will, because of their position or regular attendance at board meetings, have some familiarity with internal board operations and performance so as to provide meaningful input to the board in their self-evaluation process. Therefore, prior to the board's self-evaluation meeting, the board shall make available the self-evaluation instrument to a list of individuals


which will include but not be limited to the associated student government officers, academic senates officers, the college presidents and vice presidents, the chancellor, vice chancellors, representatives of the district's employee unions, representatives of the colleges' accreditation teams, and community members who serve on the district bond oversight committees or foundations. Any input from these individuals shall be given and reviewed at the self-evaluation meeting.

In addition, any student, community member, or employee shall be entitled to provide input to the board at the board's self-evaluation meeting.
