## IV. **Approval of Minutes** May 9, 2017

Minutes reviewed and motion moved by Louise Janus; seconded by Irene Soriano to accept the minutes as written. Approved unanimously by all Senators present.

#### II. **Presentation** Dr. Linda Rose- Guided Pathways

Dr. Rose addressed what Guided Pathways is and how the program functions. Important points:

- It needs to be faculty driven to make it successful
- Goal is to have students move through their program of study as quickly as possible
- There will be a summit for Guided Pathways in the fall and an application will be placed on the SAC website for faculty to review
- SAC completion rate is under 50%-investigation of student barriers are needed
- Guided Pathways will also include non-credit students
- Pre-requisites completion is often a barrier for the students- they feel overwhelmed
- Collaborative effort with faculty from all areas is crucial for program
- Anyone interested in being part of Guided Pathways initial planning email Dr. Rose
- Book available in the library *The Redesigning of American Community Colleges* would be helpful for faculty to read in regards to Guided Pathways.

# III. Presentation Dr. Raul Rodriguez

- Update on Saudia Arabia Project- Have been there since February and is a 3 year contract. About 8 people are indirectly working for us. They are not RSCCD employees but hired through our partner in Saudi Arabia. Fully staffed will be 16 people in fall. We are on schedule. Our goal is to assist them in building the school, starting it, managing it and improving their educational system. Biggest challenge now is the internet conductivity. First payment due in August. Hope to make approximately 1 million dollars. It benefits SAC students with district revenue. ASG has been consulted for expenditure of income. When questioned by faculty regarding when the first payment from Saudia Arabia is expected and the amount it would be Chancellor Rodriguez responded that it might be in August but no specific date or amount was stated and said he wasn't sure on either.
- 8 million ongoing structural deficit due to costs increasing from PERS/STRS/Collective bargaining agreements
- Budget Report to Board of Trustees- Phase I- 4 million in cuts no effect on operations
- RSCCD received 4 million dollars from the State going into our base so we don't have to touch the stabilization funds 28 million dollars
- Phase II-Next year the budget might affect our operations. Budget and adjustments will need to be made. Last resort is to cut jobs.
- Difficult to create more revenue due to decrease in enrollment. Two-thirds of State have decreased enrollment. Even if growth occurs growth revenue is capped at state level.
- Last fall budget/structural cuts were initially reviewed by VP's and Vice-Chancellors. Plan for next year will start in summer. Request was made to give faculty and Academic Senate ample time to evaluate next set of budget cuts prior to their inception.
- Forty-Two million dollars has been set aside for retirement program.

- Chancellor Forums will take place in the fall.
- IV. **Presentation** Maria Camarena S4S Peer Mentoring Program and possible CAI follow-up Students 4 Students (S4S) Peer Mentor Program was funded through 3SP and equity in Spring 2016. Initially piloted with 8 students and with 72 students in the program. The purpose of the program was to create a community of students that would help other students on campus and to help with students' engagement and connectedness. Students are S4S Peer Mentors who assist students in various programs on campus including the IQ bar in admissions and the Library, where they help out with SAC applications, class enrollment, and Digital Dons laptop loan program. Mentors in the Assessment Center assist counselors with class presentations to help students understand the importance of the placement test and how their results might affect the classes they get placed in at SAC. Peer Mentors connect students with counselors and other resources on campus through the Adelante Program- now to be called SAC Promise Program and with Basic Skills Counselors. Champions are peer mentors who help students connect to the Math and Learning Centers. First Year Connect peer mentors through Outreach also help students not lose their BOGs by reaching out to students when they are at risk of losing their BOGs. If you have any students interested, applications are due June 16. Students do get paid and it helps them improve their communication and leadership skills. Two semester minimum and a two year maximum commitment with a requirement of 10-15 hours per week.

# **Written Reports:**

# Planning & Budget Report – Ray Hicks

Some discussion was held about the shortfall in enrollment in 2016-17 and the unlikely possibility of going into stabilization this current year. However, while there has been some improvements to the credit enrollment, the real likelihood of going into stabilization in the 2017-18 fiscal year is high. Along with a strong marketing plan, SAC has a very good opportunity to grow in 2018-19, coming out of stabilization healthy and strong. Nevertheless, enrollment is calculated as a district, which makes SAC dependent on enrollment at SCC, as well. Clearly, this is an item we will keep very close watch over in the future.

The Quarterly Budget Performance Report was given and accepted into the record. SAC continues to function within its budgetary guidelines, in line with accreditation standards.

SAC outlined its budget reduction plan per the Chancellor's request. SAC was able to cover half of the reductions from Fund 13, one time money, and the rest from line reductions, mostly from some over-funded accounts. One question worthy to be asked is whether the cuts will be necessary in light of Governor Brown's May Revise released earlier in the month, which increased base funding, largely to cover the overall increases in the STRS and PERS responsibilities. We will know more after the state budget is signed sometime before June 30.

A workgroup has been established to help improve some of the areas identified in the recent RAR effectiveness survey and discussed at the senate retreat in February. Several members of the P & B committee have agreed to participate.

The next meeting is scheduled for June 6th, D-Day, if necessary, since it is finals week.
