SAC currently don't have high performance numbers, data shows that SAC has many programs where students haven't graduated. Ed plans haven't been mandatory, all first-time students for Fall 2019 must have

ed plans. We want to track how many of those students return for Spring 2020. Monitoring is essential, being able to look at the data will help us improve. Guided Pathways is an equity issue, all students have the right to access all of our services. Of the 10,000 students, how many students have Ed plans? How many do not? Do they have a major? How many units have they accumulated? Need to target those students.

1. Many first time students aren't necessarily coming straight from high schools, there are many students who are working adults.
