- a. Student report

b. Faculty Report

- i. Learning and Engagement Team (Guided Pathways, Pillar 4) are planning Convocation and Convocation Breakout Activities.
- ii. Administration is planning for all remote instruction in the fall. The instruction might be hybrid for all those classes that cannot be strictly online.
- iii. Suggestion from DE Advisory Group: To ensure the best possible instruction for students, require faculty to complete the Online Teaching Certification (OTC) or the proposed remote instruction certificate (RIC). Proposed RIC includes Canvas Silver Badge, Silver Certificate, Accessibility Course and new Zoom Security Course. RIC is being reviewed by the academic deans and the Academic Senate.
- iv. Suggestion: Professional Development Week may only consist of Convocation, Breakouts and Department & Division meetings. Possible workshops can include a faculty forum for remote instruction best practices and an update of all virtual student services. Equity sessions should also be offered.
- v. Non-credit Professional Development Committee propose faculty complete either the Canvas Bronze badge training or the pending RIC.
 - OEC has a different process for providing education on their campus and CEC Professional Development Committee will collaborate on best method of certification
 - 2. Non-credit will review and validate the badges and certificates for the non-credit faculty.
- vi. Counselors are requesting that they are updated as soon as possible on the final decision for the upcoming semester so they can help their students accordingly.
- vii. There is a concern for Student Professional Development and support.
