- a. Monica Zarske, Non-Payment Drop Policy A&R has requested feedback
 - i. SCC Resolution F2018.05 Recommendation for Suspension of Drop for Nonpayment Policy

- ii. Current policy: Non-payment drops are applied up until the semester starts
- iii. There is regulation in place not to drop students after semester begins unless a 'no show'
- iv. History: District approved the drop policy, but it has not always been 3 days
- v. Non-Payment Drops Analysis sheet presented with numbers
- vi. Discussion:
 - 1. Is there a study on whether we got those seats back?
 - 2. Are these students taking up a spot?
 - 3. Are there additional policies that might impact this resolution? need to develop our own information for SAC
 - 4. Mary Mettler Financial Aid as a reference? Some of the students receive financial aid which could influence policy
 - 5. Might be negatively impacting our Hispanic students; this demographic exhibits lower re-enrollment after being dropped
