- IV. AB 705 means for us- Maria Aguilar Beltran Presentation (see attached powerpoint)
  - AB 705 is new legislation that will need to be implemented Fall of 2019.
  - Changes-we now will be using high school performance data or any multiple measures, maximizing the probability of the students are completing transfer-level English and Math in their first year. Students will have the right to transfer-level courses according to the new law.
