<u>Claire Coyne</u> – presented Guided Pathways 2.0 Plans, which included important dates for submitting report and committee structures

<u>Madeline Grant</u> – is department chair per cap the faculty lead? Concerned about the amount of work being placed on faculty. Will the people on the four pillars be the same? Will these groups be making decisions independently of each other?

Claire Coyne – people from four pillars reporting to the Steering committee will be from separate groups

<u>Amberly Chamberlain</u> – Outcomes Assessment Coordinator and GP Faculty coordinator, will they be a part of this team because those position have been removed. Administration plans to bring in someone for Outcomes (possibly classified) and Director of Student Success has had similar responsibilities as GP Faculty Coordinator. How realistic are the goals presented?
