Curriculum and Instruction Council

Madeline Grant

Madeline is the new CIC chair, Vice Chair (Kristen Robinson) remains the same. Madeline discussed updates on legislation regarding AB 928 Cal GETC, AB 1111, Title V. Need to start conversations about Cal GETC this year to prepare for implementation. The 10+1 and Resolutions

Claire Coyne

Discusses Academic Senate's role and how we represent the faculty to administration. Resolutions are how faculty can get their voice out. 10+1 were provided to Retreat attendees. What does "rely primarily", "mutual agreement" mean? Ed code and Title 5 provides faculty with more power

#### Equivalencies to Minimum Qualifications

John Zarske

John discusses equivalencies, minimum qualifications, disciplines list (master's required or not required),

Claire and Exec Team members pass out forms I and II for faculty to review. Discusses Form I and II and how they are used.

Madeline Grant – how often does Form I need to be updated?

<u>John Zarske</u> – 4-5 years

Amberly Chamberlain – forms are on Senate webpage, and don't need to go through the (H) Drive

<u>Brain Sos</u> – what happens in emergency situations where there is no time to update form I with a new degree and a class needs to be taught? <u>John Zarske</u> – information regarding persons qualifications should be addressed in Form II

<u>Kim Smith</u> – Form I and II is the process for approving people with non-master degrees/certifactes as well as teaching the bachelor degree program.

<u>John Zarske</u> – it's up to the department to determine if that person is qualified to teach in the department or those courses. There is no campus-wide qualifications committee making decisions for departments

<u>Jennie Beltran</u> – can biology use the CTE tool kit for biotech positions. Can there be a separate form?

John Zarske- One form for one disciple

<u>Kim Smith</u> – would prefer to have graduate course work or professional certificate.

<u>John Zarske</u> – that is coming

Amberly Chamberlain - Can it be one graduate course?

<u>John Zarske</u> – there usually needs to be more, but it is a gray area

<u>Jacqueline Schlossman</u> - How does it work with People & Culture?

<u>John Zarske</u> – should review with departments

Jennie Beltran – as a part timer, how would they know if they are equivalent?

John Zarske – equivalencies should be posted

Madeline Grant - P&C should be more upfront with the process and more communication with Senate/Departments
