Academic Senate

Provided updates on Bachelor's degrees, funding for programs, and HR positions at the district. Updates on previous agenda items, transfer agreements, dual enrollment, purchasing timeline, & Digital Media Center.

Meeting with Dr. Nery this Friday about transfer agreements. Ashley Bootman co-chair on the DE workgroup and wants to tackle processes in DE

Informational Presentations

1) Campus Safety

Interim Chief Dave Waters

Gave a presentation on dispatch, how to call campus safety, what to expect from responding officers, & what to expect after action has taken place. Safety made references to an event that occur, which was also mention in the public comments. No one was hurt in the incident and the person was removed. Safety says Ben Hager didn't have his phone during the incident and that he passed the blue emergency phones. Officer comes in contact with Chris Wild when arriving on the scene. 2 officers are usually on duty at any time on campus. In the Hager situation, another faculty member fell in the parking lot as the office was trying to arrive to the call. Does not want to send too many Rave alerts to prevent it becoming 'white noise.' From Safety perspective, the outcome was good and didn't know Hager wanted a follow-up on the situation. Thought the situation was over and done with.

<u>Madeline Grant</u> – disagrees with the alerts becoming white noise. Would want to know if there is nothing to worry about rather than seeing something on campus and not knowing what happened or if it is safe. More communication would be helpful

<u>Safety</u> – maybe a job for PIO in many situations, but maybe not RAVE

Ann Cass – Thank you for the information. Maybe more information from PIO would be helpful

<u>Safety</u> – safety bulletins can be sent to faculty, but not students.

ASG – dispatcher 6am – 10pm. When are officer on campus?

<u>Safety</u> – 24 hrs 2 officers during the week, 1 person on the weekend. Officers receive calls on mobile phone after 10pm. Same for weekends.

Kim Smith – not always comfortable calling officers to open doors

<u>Safety</u> – that is part of our duty

2) Health & Wellness

Dr. Geena Guerrido – new psychologist at SAC

Presentation on services that are available to students through the Health & Wellness Center

Helen Serrano - it is inclusive to non-credit students?

<u>Geena Guerrido</u> – yes

<u>Rebecca Vasquez Ortiz</u> – commend the wellness center and their staff. Very welcoming and there was someone immediately to help. Thank you for serving students

<u>Helen Serrano</u> – many student taking online/remote-live courses. Are services available to those students?

Geena Guerrido – Can do in person or virtual visits

<u>Helen Serrano</u> – bilingual? Vietnamese?

<u>Geena Guerrido</u> – no Spanish or Vietnamese speaking therapist/psychologists at the moment <u>Merari Weber</u> – can faculty get any services?

<u>Geena Guerrido</u> – may provide some medical service for faculty, but psychological services are mainly for students <u>Amberly Chamberlain</u> – what is available for students afterhours?

<u>Geena Guerrido</u> – virtual is usually the way to go if students aren't here during usual business hours <u>Amberly Chamberlain</u> – most of her classes are in the evening and needed assistance. I think there needs to be discussions about a call line or service that can help students in need afterhours
