I. Call to Order

- **A.** President Hicks called the meeting to order at 1:34 pm.
- **II.** <u>Agenda Accepted</u> A motion to approve the agenda made by John Zarske and seconded by Gabriel Shweiri was unanimously approved.

III. Public Comments — (Three-minute time limit)

- **A.** A request is being made that the Student Grievance Procedure be reviewed and more widely communicated to students, faculty, staff, and administration.
- **B.** Serious concern has been raised surrounding AB361 which is calling for a complete restructuring of Continuing Education. The Governor is proposing a \$300 million statewide budget which could mean a \$4 million reduction in funding to SAC.
- **C.** Black History Month activities are scheduled for February 28 from 11:00 1:00 in The Spot. Faculty are encouraged to offer extra credit for student participation.

IV. Approval of the Minutes—

- **A.** November 27, 2012 Motion to approve the senate minutes of November 27th was made by Monica Collins and seconded by Gabriel Shweiri. The motion was unanimously approved.
- **B.** February 12, 2013 Motion to approve the senate minutes of February 12th with corrections was made by Steve Bautista and seconded by Cherie Bowers. The motion was unanimously approved.

V. Reports—

A. President—Ray Hicks

At the recent Academic Senate Legislative Affairs Committee meeting much concern was raised about AB361. Additional topics included transfer degree issues, the possibility of joint degrees, the need for credit by exam being driven by veterans and the launch of Massive Open Online Courses (MOOCs), and the Governor's proposal for a state portal for distance education classes as well as issues related to distance education including the need for orientation.

The Student Success Initiative continues to fuel concerns related to Counseling. Senate papers will be sent to you prior to the next meeting to facilitate our dialogue.

Planning for the New Faculty Institute scheduled for fall 2013 is underway. Feedback from faculty involved in the first offering of the institute is encouraged – positive, negative and suggestions for change.

Concerns raised regarding "mandatory orientation" conflicts with regularly scheduled classes will be discussed.

C. Facilities —John Zarske

An update on Measure Q progress was given including evolving maps of the campus as building and renovations are implemented. Phase 2 of the perimeter project is underway. Concerns were expressed about students walking through the parking lot in front of the A building to exit campus. This is especially dangerous at night. A request was made for additional staff parking during the construction to reduce "search" time. The next facilities meeting is scheduled for April 30th.

D. SCC - Joyce Wagner, AS Secretary/Treasurer

The SCC Academic Senate Constitutions & Bylaws have undergone significant change and will be voted on at the next meeting. Basic Skills continues to be an important topic for discussion across campus.

E. ASG Representative – Michael Burris

Activities for Women's history month are now scheduled. SAC ASG is participating in a Stop Deportation in Santa Ana campaign. RSCCD Board of Trustees President, Arianna Barrios recently met with the SAC ASG leadership. 135 Students have applied to the Student Leadership Institute. The Kinder-Carmenita event will include a voting activity. ICC rush included a performance by the Theatre department as part of the launch campaign for Welcome to Arroyos as well as an art contest. The winner's art will be used on stage during the performance. ASG elections will be held on March 21 & 22 (applications are available until March 5th).

F. Curriculum—Monica Porter

The AS-T for Geology has been approved through C&I Council. Changes regarding participation requirements in distance education were brought forward to the C&I Council by Madeline Grant and Cherylee Kushida. It has started a discussion about a potential change/addition to catalog policy. Language is currently being worked on but once finalized a recommendation will be brought to the Senate for discussion. Monica thanked faculty for their work on submission of AA-T/AS-T degrees and 2013-14 catalog review.
