#### 3. Action Item

- 1. Approval of Academic Senate LHE Distribution (2023-2024)
  - Confirmation of the total LHE available to Senate was asked. It was confirmed to be 64.
  - Confusion over whether VPs would be the Co-chairs of the Budget & Planning and Facilities Committees since they would be absolving the their LHE. It is not clearly defined in the by-laws.
  - It was stated that the Chairs would possibly be voting members of those two Committees, but not necessarily the Co-chairs.
  - Alejandro Moreno made a motion, Louise Janus seconded, to table the approval and revisit the allocation.
    - Christina asked if it can be reallocated later if not approved now. The need was to have the allocations approved so that people would know what they would be getting in time for the Senate elections.
      - *Vote to table it:* yes 5, no 15
  - Amberly Chamberlain made a motion, Christina Axtell seconded, moved to change the VPs LHE to 4 and the Co-chairs to 1 LHE each.
    - $\circ$  *Vote to reallocate: yes* 16, abstentions 3, no 1

- o Movement carried; allocations with adjustments approved
- o It was stated that these allocations would just be starting points that could still be redistributed as needed.

- 1. SCC Report Prof. Tara Kubicka-Miller
  - Senate debriefed about the retreat; felt it was a lost opportunity because Trustees were there and didn't have the freedom to discuss as needed; wanted to talk more about the IdeaBoardz; wants to have our Senates get together again to maybe discuss these together; they chose their top five that they will be focusing on.

  - 175-day Counseling Instruction proposal is now on hold, and possibly for quite some time; Cal-GETC is affecting it moving forward at this time.

  - Robert Rules and study guide was approved to be purchased for all senators and Committee Chairs; won't be purchased until the next fiscal year. Expect to have them for the Fall Retreat.
  - Moving forward three feature speakers chosen from the Speaker Series submissions; 17 out of the 19 submissions were chosen to give their presentation starting this year through the next academic year.
  - Demystifying the Hiring Process workshops have brought about a need for further workshops to lead interested faculty and classified through developing their CVs and cover letters. Look for these workshops coming in the future.
