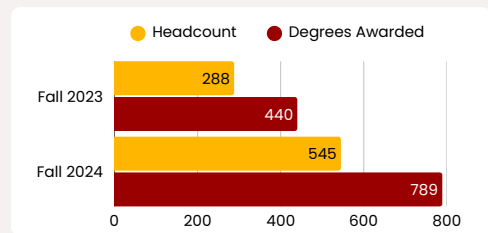
A&R ACADEMY VIDEO SERIES

DEGREE AUTO AWARD INCREASES STUDENT COMPLETION RATE

In Fall 2024, the Admissions & Records and Graduation Office launched the **Degree Auto Award** Project in collaboration with Counseling Chairs and Information Technology Services. The project involved a comprehensive review of each SAC student's coursework, aligning it with all available degree programs to assess individual progress toward completion. During the pilot, students who had completed 100% of a degree, as well as those within two courses of completion, were identified. These students received notifications either confirming their degree completion or outlining the remaining units needed. As a result, an additional **173 degrees** were awarded to another **113 students**—many of whom were unaware they had completed, or were close to completing, a degree.



Building on this success, the Spring 2025 phase of the project identified over 500 students who had either fulfilled all degree requirements or were on track to do so by the end of the semester. Given the positive outcomes and impact on student success, SAC will fully implement the Degree Auto Award Project beginning in Summer 2025 to help students graduate as efficiently as possible.

EXPANDED PRIORITY REGISTRATION

The **Priority Registration Workgroup**—composed of students, faculty, classified professionals, and managers—developed a formal process for campus programs to **apply for Group II priority registration** access. As a result of this collaborative effort, the *Puente Program*, *International Students Program*, and *MESA* were recently approved to receive Group II priority registration, following state-approved programs in the established Order of Registration.

FIRST SEMESTER ED PLANS FOR ADT DEGREES

In alignment with **AB-928** and in collaboration with Dr. Maria Beltran, Counseling Chair, SAC students planning to transfer to a four-year university will now be automatically offered an **Associate Degree for Transfer (ADT)** at the time of application. Additionally, they will receive a **pre-approved first-semester educational plan**. This proactive approach ensures students have a clear path as they register for courses during their first semester, eliminating uncertainty about course applicability to their program of study and educational goals.



FASTER STUDENT COMMUNICATION

We've **automated emails** through **Colleague**, improving how students receive updates about:

✉ **Welcome Emails** – for new students

✔ **Fraud Notifications** – for suspected fraud students

This ensures faster responses and less manual follow-up!



CRIMINAL JUSTICE & FIRE TECHNOLOGY ACADEMIES

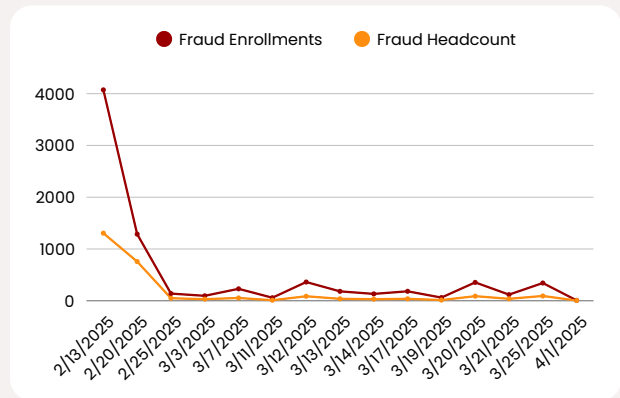
In Summer 2024, Admissions and Records piloted an electronic admissions application for the Criminal Justice and Fire Technology Academies. As with most pilot initiatives, the team made minor adjustments and refinements to enhance system functionality. The fully developed and robust version was officially launched in Spring 2025. This new, streamlined enrollment process—now live—seamlessly integrates the electronic application with online registration, resulting in a truly paperless onboarding experience for students in both academies. Special recognition goes to Dean William Reardon and Dean Ernie Gomez, along with their respective teams, for their dedicated collaboration with Admissions and Records' Technology Specialists, Jay Nguyen and Thien Pham, in making these improvements possible.

SAC's Fraud Unit Continues to open seats to REAL STUDENTS

A&R has successfully integrated **N2N's Lightleap AI** technology to **actively monitor** and **detect** signs of fraudulent enrollment. When suspicious activity is detected, students are **immediately notified** via email and asked to verify their identity using a government-issued photo ID—either online or in person. They have **5 days** to respond before being dropped from classes and waitlisted enrollments, and losing access to Financial Aid, Self-Service, and Canvas.

Since the start of Spring 2025, we've flagged and removed **2,641** suspected fraud accounts—reclaiming over **7,600** seats for real students ready to learn.

- **Summer 2025:** 2 Fraud Enrollments (*pending verification*)
- **Fall 2025:** 0 Fraud Enrollment

The Enrollment Services Team—comprised of Admissions & Records and Financial Aid—attended Ellucian Live 2025 in Orlando, FL to explore enhanced functionalities within Colleague and Self-Service. This conference supported our ongoing efforts to improve both student experiences and institutional workflows. While there, we engaged in valuable discussions with system programmers, product developers, and Ellucian partners, exchanging best practices and insights focused on optimizing student services and office operations.

Ellucian Live was an eye-opening experience. I learned practical strategies to automate graduation checks, streamline transcript evaluations, and improve student processes. I'm excited to apply what we learned to enhance our services at Santa Ana College.
