Eligibility Requirements and Documentation (AB-2133):

- ☐ I am a current active member of the Armed Forces of the United States and a CA resident. Attach a copy of your most recent military orders showing Active Status.
- ☐ I am a former member of the Armed Forces of the United States, U.S. Armed Forces Reserves, the CA State Military Reserve, or CA National Guard and have been discharged less than 15 years from the day before the term begins. **Must also be a CA resident.** Attach a copy of your DD-214, Member 4. (A dishonorable or bad conduct discharge is not eligible for priority registration).
- ☐ I am a current member of the CA State Military Reserve, or CA National Guard. Attach current status documentation or show your current non expired ID to staff.
- ☐ I will be utilizing my VA educational benefits for the above term at Santa Ana College. I intend to turn in all the necessary documents to the Veterans Resource Center at SAC to process my VA benefits as soon as I'm completely registered for the next term. Attach a copy of your current Certificate of Eligibility, Confirmation page for Form 22-1990, Form 22-5490, or Form 28-1905 for Chapter 31 - Vocational Rehabilitation.

WARNING!!! Your classes will be dropped for NON-PAYMENT AFTER 72 HOURS OF REGISTRATION, even for Chapter 33, Post 9/11 students.
This policy applies to ALL students! You can either:

1. Pay out of pocket and wait for the refund when the VA pays the school (Chapter 33 only) and the school processes the payment, OR
2. Apply for the CA College Promise Grant or FAFSA to protect your courses from getting dropped (See the VRC staff or the Financial Aid Office for details), OR
3. (For Chapter 33 only) If you refuse to apply for the CA College Promise Grant, you can request class protection directly from the VRC Director or Certifying Official for your classes. You will be asked to apply for the CCPG first before pursuing this option.
4. Vocational Rehab students should request a voucher from the Certifying Official and bring it to the Cashier's Office as soon as possible. You must have an approved 1905.
