P. Canzona reported a change in the CCN Phase I process. Previously, community colleges were informed that courses revised to align with CCN Phase I descriptors would not need to be resubmitted for Cal-GETC re-review and approval for Fall 2025. However, late last week, Articulation Officers were notified of the opposite. Now, community colleges will be required to resubmit, in December 2024, all courses revised to meet CCN template requirements for Cal-GETC approval. This significant process change means SAC faculty will need to review their CCN course outlines again, keeping the Cal-GETC resubmission in mind.
