### II. Public Comments

D. Peraza reminded faculty that, under the Brown Act, a voting CIC member may participate remotely for up to two meetings per calendar year if there is a “just cause”. He stated that W. Wang had used both her permitted meetings for this calendar year, so she was ineligible to vote.

J. Schlossman read a statement from M. Grant, FARSCCD President, urging faculty to attend the Board of Trustees’ Meeting, held today on campus, to support meeting the 30-day deadline for their contract proposal, as the Chancellor has not responded within the designated timeframe. K. Guzman added that all parties should be respectful of each other and play by the same game rules.

## **V. CIC Chair's Report**

K. Robinson stated that weekly meetings with Governet will continue until our curriculum system is fully operational and complete with all required information. She encouraged noncredit representatives to attend future meetings and thanked H. Kim and D. Khalid for their recent participation.

D. Peraza expressed his deep gratitude to all faculty involved in Common Course Numbering (CCN) Phase I. He shared that he attended the Curriculum Regional Meeting on Saturday where his frustrations with CCNs and the last-minute changes felt validated, as many faculty members from other colleges expressed dissatisfaction with how Phase I was managed. He also conveyed confidence that our CCN courses were completed correctly and that we were in a strong position with the CCNs. Additionally, he extended special thanks to P. Canzona for her guidance, expertise, and patience.

D. Peraza explained that Phase II will be divided into three clusters. The first cluster will be released in January with the remaining clusters following in subsequent months. He encouraged faculty to complete surveys, emphasizing that this is an important way to provide input.

J. Lamb announced that faculty who contributed to CCN Phase I will receive compensation for their work. He also outlined plans to hire a CCN Faculty Coordinator, a designated CCN Division Faculty Lead and offer stipends to faculty when appropriate.

Discussion followed.

The meeting adjourned at 4:00 p.m.
