V. CIC Chair's Report

A. CCN Phase I Courses – Active Programs

D. Peraza stated that the Curriculum Office will update current active programs impacted by Common Course Numbering (CCN) if no proposals were submitted during this cycle.

D. Peraza reported that the CIC Chairs and Curriculum Office staff are aware of issues in active programs, such as missing "or" statements or unit values not appearing. He explained that these problems stem from the transition from META to Maverick and assured that efforts are underway to resolve them promptly. He requested that CIC representatives inform their constituents about the situation.

B. DCIC Report

K. Robinson reported that the District CIC Meeting was held on November 6th, focusing on Administrative Regulations (ARs), Board Policies (BPs), Dual Enrollment, and Credit for Prior Learning. She noted that once the ARs and BPs are updated, they will be presented to this body for discussion and approval. K. Robinson also stated that a follow-up meeting is being planned to address additional agenda items. She will provide an update once the meeting occurs.

C. Spring Planning

K. Robinson suggested starting the quadrennial review of courses earlier. She emphasized the challenges faculty proposing Career Education (CE) programs have encountered in obtaining the necessary documentation for program approval. K. Robinson also asked CIC members if topics such as currlQunet workshops, General Education designations, and accreditation question and culturally responsive curriculum should be included in the discussions during Professional Development (PD) week.

Discussion ensued.

J. King shared that the Distance Education workgroup is exploring the development of a more userfriendly Distance Education form and considering ways to streamline the process.

D. Dumon announced plans to launch a new currIQunet module in Canvas during PD week. She also mentioned that a session on CE documentation will be offered, covering topics such as program review, when Labor Market Information (LMI) is required, how to apply for Orange County Regional Consortium (OCRC) approval, and obtaining approval minutes. Additionally, a chart outlining a proposed timeline will be shared.

VI. Announcements

D. Peraza expressed his appreciation to CIC members for their contributions. He requested that outgoing members encourage their replacements to attend CIC meetings to familiarize themselves with the process. Additionally, he encouraged new members to participate in Canvas currlQunet workshops.

VII. Other

A brief discussion focused on the process students follow when applying for degrees and the pilot implementation of program auto-awarding.

The meeting was adjourned at 3:50 p.m.
