The meeting was called to order by D. Peraza, CIC Vice Chair, at 2:03 p.m.

Ι. Approval of Additions or Corrections to Agenda

II. **Public Comments**

D. Peraza reminded members that each is permitted two online attendances per calendar year. Those wishing to attend virtually must notify the co-chairs and/or curriculum office beforehand. Members who attend virtually, require the approval from the council at the start of the meeting to vote on agenda items online. He also announced council seat vacancies for the Fine and Performing Arts and Social Sciences divisions; he and K. Robinson will contact these divisions for recruitment; K. Robinson noted that co-representatives will share the two allotted attendances and reminded members to submit Zoom attendance requests in advance.

V. Chair's Report

a. Snooze/Stretch Quad Review

K. Robinson reminded the council about the one-year "snooze" or "stretch" option for the quadrennial review and recommended using this option for updates made to Title V. The co-chairs will follow up with the divisions regarding these updates.

b. Inclusion, Diversity, Equality, and Anti-Racism (IDEA)

K. Robinson stated that, under Title V, each curriculum must establish a formal procedure for reviewing Course Outlines of Record (COR) for compliance with IDEA. These reviews must be accurate to align with the new standards. She will attend CIC training to gain a better understanding of accessibility requirements for regular modality courses.

J. Lamb suggested inviting guest speakers to provide guidance on documenting evaluation within a culturally responsive curriculum framework. This approach would enable the CIC to engage in more in-depth discussion when developing new standard documentation.

c. Faculty Minimum Qualifications

K. Robinson reported that Title V now mandates the inclusion of minimum qualifications for faculty on CORs. She stated that CIC members will be provided with the 19th Edition of the Minimum Qualifications for Faculty and Administrators in California Community Colleges as a reference for listing qualifications by discipline. She clarified that multiple qualifications may be listed using the term "or" where applicable. She further informed the council that petitions to revise minimum qualifications be submitted to the Chancellor's Office for approval by the Academic Senate. Additionally, she announced the CIC leadership is working out the final procedure to present to CIC to effectively add this information.

M. Morin explained that the intent of the CIC leads is to leverage the current primary sources for minimum qualifications that currently exist in HR and through the official equivalency process rather than create a new workflow to establish the MQs that will be placed on CORs.

d. Hanging Hours

M. Morin introduced the Standard Attendance Accounting Method, which will change how Full-Time Student (FTS) reporting is handled for state funding purposes. Under this method, the district will be funded by the unit value instead of contact hours with the exception of positive attendance sections. This may impact how the college is funded for courses that have "hanging hours" (hours that generate fractional units below .5)

J. Lamb noted that the method will help optimize student scheduling, ensuring that students gain the maximum benefit from each course to support their success.

K. Robinson stated the state has changed the student accounting method options, and we will transition in Fall of 2026. This impacts a number of blended lecture/lab courses. Faculty will be notified if the accounting for their class will change. CIC will discuss various options going forward.

e. Bachelor's Announcement

D. Peraza stated that the new Bachelor's programs have generated interest from faculty from other departments. For those considering participation, a professional development (PD) workshop is being planned. This initial workshop will primarily provide an overview on getting started with the process. Once the application has been approved by the state, a second workshop will focus on curriculum development. He suggested that non-career education disciplines (i.e., Communication Studies, Mathematics, English) get involved by developing upper division general education curriculum for Bachelor

degree programs. Additionally, he recommended that faculty interested in creating a Bachelor's degree program should get feedback from members in their advisory committees about what upper division general education courses will best support the upper-division curriculum and its related disciplines.

J. Lamb proposed creating an outline for the application process, which would include input from administration, faculty, and curriculum teams to ensure alignment with courses and programs. He also requested feedback on this process to aid in planning for the new Bachelor programs.

K. Robinson suggested that General Education participate in the Bachelor program. She informed the council that multiple applications can now be submitted for state approval.

f. Meta/Acadea updates

R. Vazquez explained that course sequence and enrollment data must be entered for each course under the "Course Requirements" tab. This information allows the system to generate the program narrative directly from CurrlQunet. If all required fields are completed, the Word document for the narrative can be replaced with the program narrative report generated by the curriculum platform. K. Robinson and R. Vazquez reminded the council to reach out to the curriculum office for any assistance related to Meta/Acadea.
