II. Public Comments

A. Gates expressed her concerns regarding the development of noncredit real estate courses under the Vocational Business (VBUS) subject area.

- J. Kennedy welcomed the committee to the School of Continuing Education (SCE), expressing his appreciation for the collaboration and noting that it is a pleasure to host the Curriculum and Instruction Council (CIC) twice each semester.

V. Course Materials

P. Canzona clarified that textbooks listed in the Course Materials tab in CurrlQunet that are more than five (5) years old must include a clear rationale. She emphasized that simply stating the text is the most recent edition is insufficient; instead, a stronger justification, such as the text being a classic or foundational work, must be provided. She also highlighted that the Assignments tab is sometimes viewed as a "hidden treasure" by CSU and UC reviewers. In light of this, more detailed information in the assignments section to support the content and objectives can help earn course approval.

K. Robinson added that, due to recent updates to the Chancellor's Office Curriculum Inventory (COCI), examples of in-class reading and writing assignments are now required. As a result, greater specificity will be necessary in the Methods of Instruction tab.

Discussion ensued.

VI. Program Maps

M. Macintyre gave a presentation on program maps, explaining that counselors are currently updating maps that date back to 2018–2019. She emphasized the goal of fostering collaboration and creating a consistent process for maintaining up-to-date program maps. M. Macintyre noted that the purpose of program maps is to provide students with a clear, easy-to-follow overview of their educational pathway. Additionally, the maps will serve as outreach tools for departments and will be easily accessible through the Santa Ana College (SAC) website. She also discussed the alignment of program mapping with strategic initiatives, such as Guided Pathways, SAC Completion Goals and SEAP, and highlighted the implementation process, the collaborative development approach, and faculty expectations.
