The district received a cost of living adjustment of 4.23% and growth was budgeted at 2.5%. Mrs. Kanouse reported that system-wide Equalization was at 30,000,000 and Partnership Funds were 31,409,000.

### ☐Funding for Community Colleges

✓ Total State-Determined budget was noted at 5.7 billion. Funded FTE's were at 1.17 million, which reflected twice as many as the CSU and UC systems.

### ☐Budget Activity Summaries

✓ Cash flow reports were presented for all sites and for Santa Ana College reflecting 2003/04 and 2004/05.

# □General Fund Budget

✓ Mrs. Kanouse presented members with a copy of the general fund budget. She reported that the budget will be presented to the Board for approval on September 13<sup>th</sup>.
