Construction to begin in June. <b>SAC Baseball Complex</b> A notice of completion will be filed.

	<p><b>Wash Your Hands Signage</b> The committee was approached by the ASG Health Commissioner, Ricardo Garcia regarding the need to have "wash your hands" reminders in the restrooms.</p> <ul style="list-style-type: none"> <li>• The committee was in favor of such action.</li> </ul> <p><b>Smoking on Campus</b> Ron Jones provided some background on the removal of the butt receptacles. He reported that last April/May all but 4 of the butt receptacles were removed due to all the complaints from staff. It appeared that smokers were congregating around the receptacles hence the area becoming a smoking hub. A discussion ensued regarding SAC's decision to be a "smoke free" campus. At that time, proposed signage was presented to the committee for input and review.</p> <ul style="list-style-type: none"> <li>• It was informally recommended that the "smoking issue" be brought back to College Council.
