I. Call to Order

Dr. Flores welcomed all and called the meeting to order at 9:06 a.m.

1. Approval of Minutes – Monica Zarske made a motion to approve the September 23, 2020 minutes, with Dr. Hubbard seconding the motion. The motion was approved with no opposition or abstentions.
2. President's Report – Dr. Flores emphasized that managers are responsible for continuing to assess campus offices and areas as we continue to plan for the slow, gradual and staggered return to campus. She asked administrators to continue planning schedules with staff that are available to return to campus at present time. She noted that our planning efforts are following District, County and State guidelines and that many K-12 districts are opening up. She stressed the importance of honoring the MOUs with FARSCCD and CSEA as planning continues for the return to campus. Dr. Flores will request clarification from H.R. related to the verification needed from faculty and staff who are not able to return to campus at this time. Dr. Flores to prepare an email to all students regarding the F2F PPE and social distance guidelines. She noted the Athletic conditioning classes are scheduled outdoors with PPE and social distancing included. She provided an overview of the COVID-19 testing schedule at SAC. New guidelines require the number of COVID-19 cases to be posted and will be done by the District Office in an aggregate format.
