IMPORTANT DATES FOR FACULTY—SPRING 2024

FULL TERM COURSES

- o **FEBRUARY 11** LAST DAY TO REGISTER WITHOUT ADD AUTHORIZATION
 - o **FEBRUARY 12-25** ADD PERIOD WITH ADD AUTHORIZATION
 - o **FEBRUARY 25** LAST DAY TO DROP WITH A REFUND AND WITHOUT A “W”
 - o **MAY 12** LAST DAY TO DROP WITH A “W”
- Refer to Self-Service for courses that fall outside of the full-term calendar
 - Please note that online add authorizations only work during the add period
 - After February 25th a late add petition is required. Find the form [here](#) or at sac.edu/forms
- Per Title 5, § 58004, students are required to be dropped for no-show

AUTO-ENROLLMENT FROM THE WAITLIST

Waitlisted students are automatically enrolled at 10pm nightly when space becomes available. Since the rollout in December 2023, we have auto-enrolled 433 students from the waitlist! Auto-enrollment upholds all registration rules such as pre-requisites, time conflict, and repeatability rules. This will help ensure that students get into classes they need to stay on track for timely graduation! Based on faculty feedback, A&R will be working with ITS this Spring to further streamline the overall waitlist functionality.

UPFRONT EVALUATION: PHASE II IN THE WORKS!

The AR III team is moving into Phase II of upfront evaluation after a successful roll out of Phase I. We are expanding GE evaluation into nearby regions including Riverside and San Diego Community College Districts. Stay tuned for more information on pre-requisite clearance!

ID.ME IS LIVE ON CCCAPPLY FEBRUARY 2ND!



ID.me has been integrated with CCCApply to verify students' identities and assist with the high volume of fraudulent applications. No action is required of our current students. Minors, students with housing insecurities, and those without online access can use the opt-out process. Used by many State and Federal agencies, ID.me is an easy way for students to claim and validate their identities and it also speeds up the verification process from the previous manual process conducted by Admissions and Records staff. REGISTRATION RESTRICTIONS FOR SPECIAL PROGRAMS NOW LIVE

Spring 2024 registration restrictions are now live for the OCTA and Hope Builders programs! Using CORM flags, students for these special programs can now register themselves online instead of having to submit add cards to A&R. More programs will be added soon!

CCCApply applications are valid for one year! If a student applies for Spring 2024, but doesn't take classes, they won't have to reapply until Spring 2025!



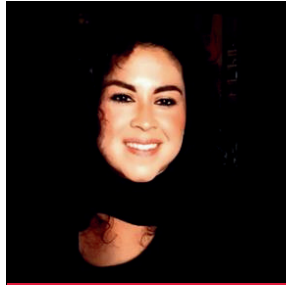
YOUR LIFE GOT EASIER WITH OUR LATEST UPDATE

Waiver for High School Students

In collaboration with the Cashier's Office, High School students who are categorized as Non-Resident through CCCApply will now automatically have their non-resident status waived. This implementation removes the need for students to change their residency status while streamlining the workflow within A&R and Dual Enrollment.

To better align with state guidelines and regulations, our CA Residency determination process has been updated. Students are required to provide two documents: one showing their physical presence for a minimum of one year and one day in CA and another document that shows their intent to stay in CA. Only one of these documents must be dated one year and one day before the term starts. Approximately 500 Spring 2024 non-residents received an email from A&R on February 8, 2024 with the CA Residency and AB540 Forms to determine eligibility. Both forms may be submitted electronically! Feel free to direct students to A&R or provide them with the link to the [dynamic form](#).

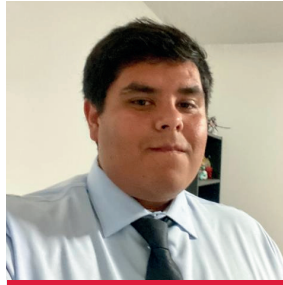

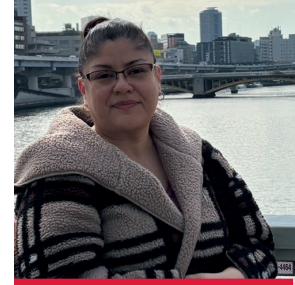

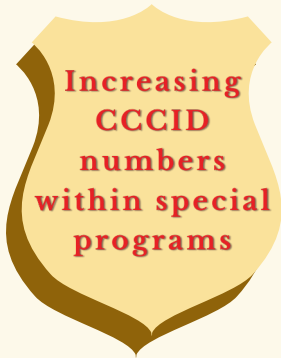

The CCCID is a unique identifier created for students that enter the community college system. It is generated when an individual creates an OpenCCC account—typically during the application process. CCCIDs are an important factor in MIS reporting, which is used to calculate district apportionment. The CCC Chancellor's Office is requiring colleges to increase CCCID numbers attached to student records. A&R is working closely with departments and ITS to find ways to increase CCCIDs within our campus programs with batch creation of CCCID numbers and encouraging our partners to have students create an OpenCCC account prior to taking courses.

OMG!! DYNAMIC FORMS

Since launching dynamic forms in September 2023, the A&R Team has processed **over 1,800 digital forms** for our students! Below you will find a summary of all Dynamic Forms from A&R split into two categories based on who initiates the form.

Fall 2023 Degrees and Certificates Conferred to Date

- 496 local and transfer degrees
- 1,098 certificates of achievement
- 223 certificates of proficiency
